Medical, dental, and vision coverage

Medical cover and hospitalisation: Get Intuit-provided coverage for hospitalisation and medical expenses up to INR 5 lac for you and your family. You can opt to increase your coverage at group policy prices.

OPD, dental, and vision reimbursement: Get reimbursed up to INR 30,000 per fiscal year for outpatient department (OPD) services.

Online consultations: Book free, unlimited online consultations with general practitioners, pediatricians, gynecologists, dermatologists, and nutritionists.

Annual health checkup: You and one registered dependent have access to a variety of no-cost examinations, tests, and screenings at leading hospitals and diagnostic centres.

Financial benefits
